## Job Description

The Internship will involve three major components— shadowing current employees within each functional area of the firm, a company or industry related project to be completed and presented to the Management Team at the end of the internship, and engagement with Memphis’s non-profit sector. The ideal candidate will thrive in a fast-paced environment and will be able to manage many different tasks. This position will provide the individual an opportunity to gain experience and be exposed to all areas of the firm, allowing them to understand how each department works together to accomplish the firm’s overall goals. The project and the community-centric aspects are important parts of the Internship as well. This 8-week project will provide the Intern with an opportunity for investment-related research as well as an opportunity to present the project's findings to the SouthernSun Management Team. The community-centric focus will afford the Intern insight through an experience with Memphis's non-profit sector. Finally, each Intern will be assigned a mentor from the firm’s employee base to assist with the Intern’s acclimation during their time at SouthernSun.
